

Changes To 2022 RWT Plan

Our customers did not opt to utilize our ONC certified functionality that was listed in the original plan in 2022. However, as part of the NSS release process, we have tested the functionality internally throughout the year. As part of Cures Update attestation for NSS version 11 we have done extensive testing and documented all functionality and fixed some functionality. The original plan was for version 10 that was 2015 Edition certified. In November 2022 NSS successfully completed ONC Cures Update certification and updated version to 11 (details listed in this document).
